The Index Information will be classified as additional Information under clause 2.2 of respective agreements with the following condition (Terms used in this letter, unless otherwise defined, have the same meanings as defined in respective agreements):

(i) Market Data Vendor Licence Agreement

Clients are permitted to (i) use the Index Information and (ii) disseminate the Index Information to your Subscribers for their internal use only and not for further dissemination, in accordance with the terms of the Licence Agreement at no additional charge.

(ii) Market Data Application Service Provider Agreement

Clients are permitted to (i) use the Index Information and (ii) disseminate the Index Information to your Indirect Connection Licensees, in accordance with the terms of the Licence Agreement at no additional charge.
